"A" ORDINARY RESOLUTION

That the members hereby approve the Club spending a sum not exceeding ten thousand dollars (\$10,000.00), (2024 FY \$8,512) until the next Annual General Meeting for the following expenses but in each case subject to approval by the Board of Directors in accordance with section 10(6)(d) of the *Registered Clubs Act*:

- (a) The reasonable cost of a meal and beverage for each director immediately before or immediately after a Board meeting on the day of that meeting;
- (b) The reasonable cost of directors travelling to and from directors' meetings and other duly constituted Board or subcommittee meetings on the production of relevant invoices, receipts or other proper documentary evidence of such costs;
- (c) The reasonable cost of directors attending the Annual General Meeting of Clubs NSW and conferences conducted by Clubs NSW;
- (d) The reasonable cost of directors attending seminars, lectures, trade displays, organised study tours, fact finding tours and other similar events for the education of directors as determined and approved by the Board from time to time;

The members acknowledged that the benefits and expenditure pursuant to this resolution are not available to members generally but only to those members who are directors of the Club.

Notes to Members on Ordinary Resolution

1. Consistent with the widespread practice of registered clubs the directors are seeking approval from members for expenditure incurred by directors in the course of carrying out their duties.

Procedural Notes for Ordinary Resolution

- 1. To be passed the ordinary resolution requires votes from a simple majority of those members who being eligible to do so vote in person at the meeting.
- 2. Proxy voting is not permitted under the *Registered Clubs Act*.
- 3. Members who are employees of the Club are prohibited from voting by the *Registered Clubs Act*.

"B" ELECTION OF LIFE MEMBER RESOLUTION

Notes to Members

- 1. Life membership may be conferred on any RSL member or Club member who has rendered outstanding or meritorious service to the Club for a period of at least ten (10) years.
